

## **REGULATIONS CORRI TRIESTE TEN 2024 NON-COMPETITIVE 10 KM ROAD RACE**

The A.S.D. Promorun Trieste, in cooperation with the Municipality of Trieste and the Friuli Venezia Giulia Region, is organising the second edition of Ten Corri Trieste, a non-competitive road running event. The event will take place in all weather conditions. The presence of a doctor and ambulance service will be guaranteed. The organising company accepts no liability for any damage to persons or property that may occur before, during or after the event.

By registering for the race, the athlete declares that he has read and accepts these regulations in full.

### **REGISTRATION**

**Maximum number of participants 400 participants in total between the competitive race and the non-competitive Ten.**

**Online registrations will be closed at 23:59 on 15 May 2023 or when the maximum number of 400 participants is reached.**

Online via the Endu portal payment by credit card or bank transfer. In the case of payment by bank transfer, please use the details provided at the end of the registration process.

## **NOT PRE-ENROLLED**

It will be possible to register for a fee of € 20.00 at the Corri Trieste registration centre at Trieste Villas, via Torino 34 Trieste on Saturday 18 May from 10.00 a.m. to 7.00 p.m. and on Sunday 19 May from 7.30 a.m. to 8.30 a.m. in Piazza Venezia start area.

Entries without the required documentation (see privacy form at [www.corritrieste.it](http://www.corritrieste.it)), or with incomplete contact details and personal data will not be accepted.

## **REFUNDS AND TRANSFERS**

Participation fees are non-refundable; it is not possible to transfer one's registration to another athlete or to another edition of the event.

## **PARTICIPATION REQUIREMENTS**

Run open to all, no medical certificate required.

## **BIB AND RACE PACKET COLLECTION**

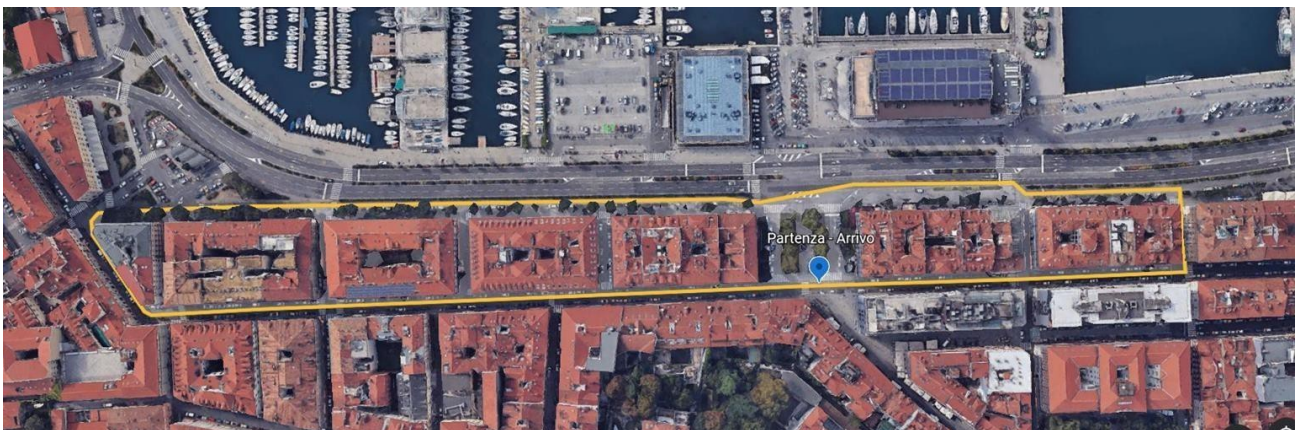
The location, days and times of the registration centre will be announced through the event's social channels and on the event's official website in the days leading up to the event. you can pick up your race package at the Corri Trieste registration centre.

Please come to the pick-up with a completed privacy form ([HERE](#)).

In the case of collection by proxy, the delegating party must fill in, sign and hand over to the delegate the proxy form ([HERE](#)), the privacy form ([HERE](#)), a copy of the registration confirmation letter and a copy of his/her ID.

## ROUTE

10 km on road; route completely closed to traffic with start and finish at Piazza Venezia, with two very fast straights, one inside the city centre and the other facing the sea. A 1,250 m track to be repeated eight times.



## LIMIT TIME

The time limit for finishing the competitive 10 km race is set at 1h10', beyond this time the Organising Committee will no longer guarantee control and assistance on the race route.

## RISTORI

There will be a refreshment point at km 5 and one in the finish area.

## RANKINGS AND AWARDS

Entrants are not included in any ranking and are not entitled to prizes.

## BAGS DEPOSIT

Bag storage is not provided. All athletes are requested to leave their bags in their cars and to arrive at the start area in their race clothing. It is strictly forbidden to leave any clothing inside the start area or along the route.

## **RIGHT OF IMAGE**

By registering for Corri Trieste 2024 the athlete authorises the organisation to acquire, free of charge, the right, together with its partners, to use the still or moving images on which he/she may appear, taken during his/her participation in Corri Trieste 2024, on all visual media as well as on promotional and/or advertising materials.

## **FRAUDULENT PARTICIPATION IN THE TENDER - PENALTIES**

The subscriber is responsible for the ownership and safekeeping of his or her race bib and acquires the right to use all the services mentioned in these regulations and subsequent announcements.

1. Anyone who participates without regular registration, in addition to being held liable for damage to persons or property, including himself, will incur sporting sanctions under the jurisdiction of the federal bodies and may be liable to the criminal penalties provided for the offence of 'theft' (Art. 624 of the criminal code).
2. Anyone who, without regular registration, takes part with a counterfeit or otherwise non-compliant bib number, in addition to being liable as indicated above, will incur sporting sanctions and may also be liable to the criminal penalties provided for the crime of 'theft' (Article 624 of the criminal code), or, alternatively, the crime of 'fraud' (Article 640 of the criminal code).

In cases 1 and 2, participants may be liable to the penalties provided for the offence of "failure to comply with the provisions of the Authorities" (Article 650 of the criminal code). The aforementioned cases will only be found after verification of photographic and/or video documentation.

## **FINAL WARNINGS**

The Organising Committee reserves the right to amend these regulations at any time for reasons it deems appropriate for the better organisation of the race, after having given notice to and obtained approval from the FIDAL. For anything not provided for in these regulations, the technical statutory regulations of the FIDAL and the G.G.G. apply. Any changes to services, places and times will be duly communicated to registered athletes or will be posted on the website [www.promorun.it](http://www.promorun.it). In addition, the documentation containing the essential information for taking part in the race will be delivered by the organisation together with the bib.

## **CANCELLATION OF COMPETITION - NON-EVENT**

In the event that the race is cancelled, moved to another date and/or not held due to causes beyond the control of the organisers, including the withdrawal of authorisation to hold the race by the competent public bodies, atmospheric events, earthquakes, epidemics and any other event that may jeopardise the safety of the participants, the participant shall not be entitled to claim any reimbursement from the organisers. Registrations received will be kept valid for the following year or for another Promorun event. The transfer will be completely free of charge.
